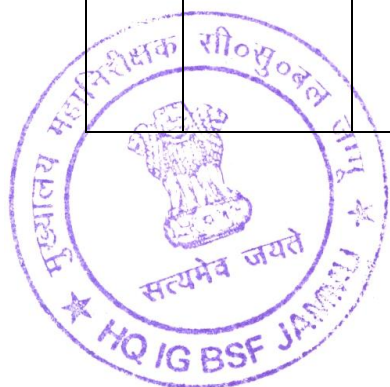


**RECRUITMENT TO THE POST OF PARA MEDICAL STAFF IN

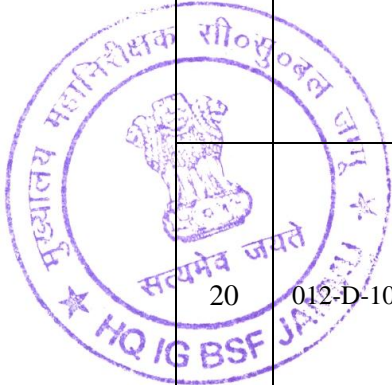

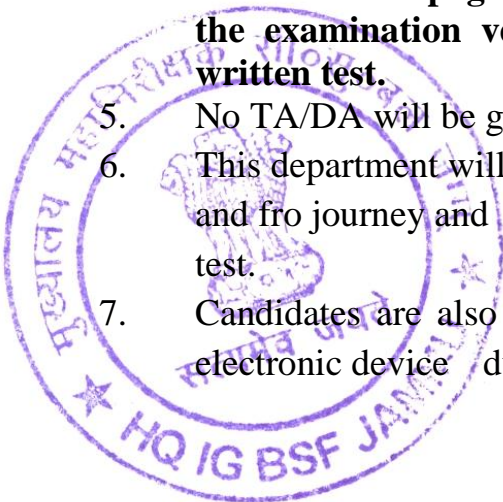

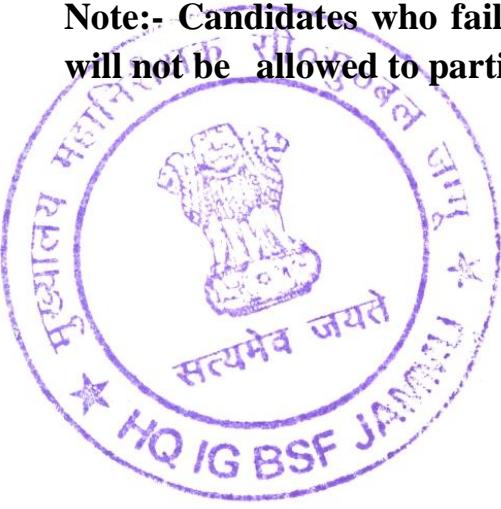
